1. ANNOUNCEMENT

The Queensland Early Motorcycle Sports Club Incorporated, hereafter called the PROMOTER will conduct the Stanthorpe Test N Tune practice weekend & Come & Try day at Carnell Raceway, Stanthorpe, Qld on Saturday and Sunday 12th & 13th of March 2016.

2. ENTRIES

- 2.1 On-time entries open forthwith and close on Friday 4th of March. Late entries may be accepted up until Friday the 11th of March with a \$30 late payment fee.
- 2.2 In the case of postponement or abandonment of the event, all or any part of the entry fee may be retained by the promoter, if such retention is approved by Motorcycling Queensland.
- 2.3 Only entries received on the official entry form that is accompanied by the correct fee will be accepted.
- 2.4 RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING WILL BE CONSIDERED ONLY IF NOTIFICATION IS GIVEN AT LEAST ONE WEEK PRIOR TO THE RACE DAY.
- 2.5 ALL ENTRIES TO BE POSTED TO: David Vincent PO Box 282, Goondiwindi. Q 4390
- 2.6 Machines cannot be cross entered in more than one group.
- 2.7 Come & Try entries will be processed on the day (Sunday) & licenses for this one day event are free to anyone that has never held a full race license.

3. ENTRY FEE

- 3.1 An on-time entry fee of \$90.00 will be charged for all senior solo and sidecar competitors. A late entry fee of \$30 may be charged for entries received after 4th March. All riders must have a current MA Competition license or purchase a Recreational licence which will be available on the day at a cost of \$25.
- 3.2 Payment by cheque, money order or EFT. **ANY FEES FOR DISHONOURED CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT.** Cheques and money orders are to be made payable to QEMSC. For those wishing to pay by EFT please make the payment to QEMSC, Bank of QLD, BSB; 124001 Account number; 10419361. Please insert your name as the reference, print the transfer confirmation & post with your completed & signed entry form.
- 4. GROUPS: These are the approximate groups that will be run over the weekend. Normal track capacity limits to not apply to practice events.
 - 1 # Sidecars
 - 2 # Historic Period 2 & Period 3
 - 3 # Historic Period 4 & Period 5
 - 4 # Historic Period 6, GP125 & Supermotard
 - 5 # NCRR: Superlite, Motolite & Stockers (If minimum numbers are not reached these will be run with another group)
 - 6 # Regularity: Any road machine up to 1990 manufacture
 - 7 # Come & Try event (Sunday only) Any road or race machine up to December 1990 manufacture
 - 8 # Juniors will be given some track time on both days at the discretion of the practice supervisor. Juniors must hold a current MA license or purchase a recreational license to be able to participate.
 - Note 1: The exact make up of groups will be decided once entries close.
 - Note 2: Each machine is only allowed to be entered in one group

5 INSURANCE

- 5.1 MA's National Personal Accident Scheme provides basic cover for death and permanent disability only.
- 5.2 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE. ALTHOUGH ALL QLD RESIDENTS HAVE AUTOMATIC AMBULANCE COVER IT IS MANDATORY THAT INTERSTATE COMPETITORS TAKE OUT AMBULANCE COVER IN THEIR OWN STATE.

6. MEDICAL SERVICES

A QAS ambulance will be in attendance between 11am-5pm on Saturday and 10am-4pm Sunday.

7. NOISE

ALL MACHINES MUST COMPLY WITH A 105dba RIDE BY TEST AT 10M FROM THE EDGE OF THE TRACK (2016 MANUAL OF MOTORCYCLE SPORT RULES 12.10) MACHINES MEASURED OVER 105dba WILL BE UNABLE TO PARTICIPATE UNTIL THE NOISE IS REDUCED TO THE ACCEPTED LEVEL.

8. RIDERS BRIEFING

A riders briefing will be held prior to the commencement of the first practice session of each day and **ALL Entrants MUST attend**. Riders Briefing is a NON Smoking Area.

9. CIRCUIT DESCRIPTION

Carnell Raceway is approximately 1 km in length. Its surface is constructed of hot mix bitumen. Riding will be conducted in a clockwise direction. Push starting of machines in pit lane will only be allowed in a southerly direction towards the entry gate.

IMPORTANT NOTES:

- 1: **FUEL**: is not available at the track.
- 2: **ALCOHOL**: IS NOT PERMITTED WITHIN THE PIT AREA WHILE THIER IS ON TRACK ACTIVITY. RIDERS CONTRAVENING THIS RULE WILL BE EXCLUDED FROM THE DAY'S EVENTS.
- 3: **CHILDREN ON WHEELED DEVICES**: OF ANY KIND ARE NOT PERMITTED IN THE PIT AREA. These devises will be confiscated and returned at close of racing. CHILDREN UNDER 16 YEARS OF AGE ARE NOT PERMITTED IN THE PIT LANE.
- 4: **DOGS:** ARE **NOT** ALLOWED WITHIN THE CIRCUIT GROUNDS AT ANY TIME.

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

2. DEFINITIONS In this declaration:

- means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its
- constitution or regulation; "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited;
 "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
- "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation e)
- event, meeting or activity;
 "Motorcycling Organisation" means and includes MA, and the MA
 members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

I ACKNOWLEDGE that:

- motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed
- that my machinery or equipment may be damaged, lost or destroyed;
- that competitors may ride dangerously or with a lack of skill;
- iv) that track or event conditions may be hazardous and may vary without warning or predictability;
- that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events
- that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- that I have an obligation to myself and to others to act safely and vii) within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

4. WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are: - rendered with due care and skill:

- as fit for the purpose for which they are commonly bought as it is
- reasonable to expect in the circumstances; and - reasonably fit for any particular purpose or might reasonably be
- expected to achieve any result you have made known to the

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part.

"Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include

I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

I acknowledge and agree that if required, the Indemnitees (or any of

them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

7. PRIVACY
