1. <u>ANNOUNCEMENT:</u>

That Motorcycling NSW Ltd, herein after called the PROMOTER will conduct the 2015 NSW Road Race Championships for Historic and Modern Solos and Historic and Modern Sidecars at the Sydney Motorsport Park, on Saturday 11th & Sunday 12th JULY 2015.

2. JURISDICTION

- The meeting will be held in accordance with the current Manual of Motorsport Rules (MOM's), these Supplementary Regulations, the By-Laws of Motorcycling NSW and any Final Instructions. By entering this meeting all parties agree to comply with these rules, regulations, by-laws and instructions.

3. ENTRIES:

3.1 Entries open forthwith and close last mail Friday 19th JUNE 2015

- 3.2 For inclusion in printed programme & early bird fee; entries need to be received by Friday 12TH JUNE 2015
- In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the promoter, if such retention is approved by Motorcycling NSW.
- 3.4 Only entries received on the official entry form that are accompanied by the correct fee will be accepted

3.5 <u>NOTE</u>: LATE ENTRIES WILL NOT BE ACCEPTED AND THERE WILL BE NO RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING.

Limitation of Entries. Sydney Motorsport Circuit (formerly Eastern Creek) is licenced to run a maximum number of 50 solos and 35 sidecars per race. Therefore acceptances will be determined by the Promoter, based on the receiving date of entries.

4. <u>INSURANCE</u>

- 4.1 National Personal Accident Scheme provides basic cover for death and permanent disability for M.A. licence holders.
- 4.2 Ambulance Insurance is compulsory for licensees.
- 4.3 It is strongly recommended that competitors give consideration to taking out weekly benefits insurance.

5. MEDICAL SERVICES:

Ambulance Service Australia will provide medical facilities in accordance with Motorcycling NSW regulations from 9am to 5.00pm, Saturday 11th and Sunday 12TH July 2015.

6. ENTRY FEE:

6.1 Solo Early Bird Entry (Paid by 11/6/15) \$345.00

If paid after 11/6/15 & before 19/6/15 \$390.00

Sidecar Early Bird (Paid by 11/6/15) \$358.20

If paid after 11/6/15 & before 19/6/15 \$403.20

Each additional machine/s and/or classes entered will require an additional entry fee of \$60.00 plus additional transponder hire of \$15.00 per machine. (See point 27 for information regarding transponder security deposits)

Garage space will be allocated by the promoter. A minimum of six solo machines will be allocated per garage at a cost of \$45.00 per machine and three sidecars will be allocated per garage at a cost of \$90.00 per machine. Please stipulate who you would like to be pitted with; alternatively the promoter will allocate your garage space.

Carports can be hired for a cost of \$100.00 each.

- Payment by Direct Deposit, Cheque or money order only.

 ANY FEES FOR DISHONOURED CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT
- 6.3 Cheques and Money Orders are to be made payable to Motorcycling NSW
- 6.4 Please include a self-addressed, stamped envelope for confirmation of entry and the issuing of entry passes and any final instructions.

NO ENVELOPE - NO PASSES - NO FINAL INSTRUCTIONS

7. ENTRY PASSES:

Three (3) passes will be allocated for each solo entry – Four (4) passes for sidecars and 1 additional pass for registered licensed entrants. Additional passes may be purchased at the concession rate of \$15.00 per day i.e. (\$30.00 – 2 day pass)

- P3 350cc, P3 788-1300cc, P4 250cc, P6 132-250cc
- Modern & Pre Modern 600cc 4 cyl, 675cc 3 cyl, 750cc 2 cyl & 250GP
- P5 350cc, P5 Formula 750, P6 788-1300cc
- Modern & Pre Modern 125ccGP, 250CC Single Cylinder, 250cc 4 Stroke, 400cc & Period 6 125cc
- P3 500cc, P4 526-1300cc, P5 788-1300cc
- Sidecars Classic/Post Classic/Forgotten Era and Modern F1 & F2 & Unlimited.

9. AWARDS:

Trophies will be awarded for each class on a point score that will be totalled after the final round. The basis for the points will be taken from the MOM's GCR: 13.12.19 (Moderns) & 14.10.12 (Historic)

10 ENTRIES TO CONSTITUTE A CLASS:

- To constitute a class, the number of contestants entered and competing in each class shall be 10 solo machines and 6 sidecars entered. Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and redistribute any awards, will be at the discretion of the promoter.
- Should entries be oversubscribed for any event; cross-entries will be the first to be eliminated. Pre 1991 machines will not be eligible for reserve riders list in modern races.

11. RACE FORMAT:

- 11.1 See proposed programme of events on page 6 of these regulations.
- Scoring as per MOM's.13.12.19 (Moderns) & 14.10.12 (Historic). Results will remain "Provisional" until ratified and confirmed by Motorcycling NSW.

12. MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the classes listed in paragraph 8.
- Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3 Change of machine or rider is permitted up to 30 minutes prior to the event provided that NOTICE IN WRITING is given to the Clerk of Course and Secretary of meeting.
- All pre 1991 machines entered in historic events must have a MA issued Historic Log Book.
- 12.5 All Historic machines must have front & rear calipers lockwired and Modern machines must have front callipers lock wired.
- OILTRAPS: All vents, overflow or similar fittings that allow the release of oil, fuel, cooling, hydraulic, or other liquids, shall be connected to suitable collecting devices to prevent free release of the fluid. Such collectors shall have the minimum capacity of 500mls.
- 12.7 Machine scrutineering will be conducted in separate classes as per signage displayed at scrutineering i.e. P4 & P5, P6, Moderns & Sidecars etc.
- 12.8 LEATHERS MUST BE WORN TO SCRUTINEERING. Helmets, Back Protectors and Gloves must be ready for Inspection.

13. RIDING NUMBERS:

Wherever possible, competitors will be allocated their Motorcycling NSW Registered Riding Number or their preferred riding number. All others shall be allocated numbers at the promoter's discretion.

All number plates and number sizes on all machines MUST comply with the MOM's.

14. *FUEL:*

Must be as per 2015 MOM's and fuel testing may take place during the meeting.

15. <u>ELIGIBILITY:</u>

eligibility.

All machines are to be eligible in accordance with the MOM'S for their relative disciplines: Moderns; Chapter 13 and Historic; Chapter 14.

Any machine found ineligible will forfeit any award and may be excluded from the meeting.

Overseas competitors' machines must comply with either their own competition rules or those of Australia and not be a combination of both to gain a competitive advantage.

It is the entrants/riders responsibility to ensure their machine is eligible for racing.

Machines must be eligible for historic and/or modern competition and endorsed by the eligibility scrutineer.

Entrants should come prepared with <u>original</u> documents to prove eligibility of major components. Copies of documents <u>will not</u> be accepted. Approval at previous events does not automatically guarantee acceptance of



16. RESERVE RIDERS:

- 16.1 If an event is oversubscribed then any entry received after the grid is full will be a reserve entry, unless the rider requests that his entry be withdrawn and entry fee refunded.
- Reserve riders will be accepted into an event after another rider has confirmed with the Clerk of Course that he/she will not be competing in any further events on the day. The reserve rider can then compete in the next heat for that event.
- All reserve riders must ride in the warm up/practice session to be eligible to race if a position becomes available.
- If a reserve rider gets to participate in only part of the event then he/she may receive a pro- rata refund of the entry fee.
- Once a reserve rider's entry is accepted then no further refund of entry fee will be made should for some other reason, he/she does not complete the remaining heats for that event.

17. GRID POSITIONS:

Grid positions for leg 1 for each event will be from qualifying. Grids for subsequent heats will be the finishing order from the previous leg of that event. If any rider, for whatever reason, does not appear in the results of the previous leg; will be gridded at rear of grid for the next leg.

18. RIDERS BRIEFING:

A compulsory riders' briefing will be held prior to the commencement of events on both days. ALL competitors MUST attend. Riders' briefing sign-on sheets must be signed by the competitor as confirmation of attendance.

19. DRUG AND/ OR ALCOHOL TESTING:

Random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.

20. CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia CODE OF CONDUCT contained within MA's Member Protection Regulations, found in Appendix 3 of the MOM's, which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and shall be enforced.

For the purposes of drug & alcohol testing, the commencement of the meeting will be deemed to be **6.30am Saturday** with the completion of the meeting for the participant being at the completion of the meeting.

22. CIRCUIT DESCRIPTION:

Sydney Motorsport Park (formerly Eastern Creek) is situated near Blacktown, some 34 kilometres west of Sydney. It is a hot mix circuit of GP standard and is 3.93 klms (old GP circuit) in length. Racing will be in an anti clockwise direction as specified in the permit application.

23. <u>STARTS:</u>

Will be by lights and should these fail, by the raising of the National flag.

24. RACING:

Each class of machine will be allocated approximately 10 mins qualifying time. If the number of entries in a class is less than the specified number these classes may be combined. The maximum grid number allowed per event is 50 solo machines and 35 sidecars. Riders' should be warned that this period will be their only opportunity to qualify in their class.

25. NOISE:

All machines must be constructed in a manner so that their maximum noise emission on the track does not exceed 95dba in the standard 30 metre ride by test. As required by the Environmental Protection Authority, a noise-monitoring machine is installed at the circuit. Machines not complying may, at the discretion of the Clerk of Course, be excluded from the meeting. Noise testing may take place at any time at the discretion of the Chief Scrutineer or the Clerk of Course. Refer to GCR's for details.

26. CIRCUIT ADMISSION CHARGES:

\$35.00 for adults (2 days)

\$20.00 for adults on Saturday

\$20.00 for adults on Sunday

Children under 12 years are free.

\$15.00 concession tickets (both Saturday and Sunday).

Entrants may obtain additional tickets if required, at the concession rate.

27. TRANSPONDERS:

- 27.1 Transponders will be used for the purpose of obtaining lap times and scoring
- The hire of ONE of these units is incorporated in the entry fee. Competitors entering multiple machines will be required to pay a further \$15 transponder hire for each extra transponder required.
- 27.3 Competition Licences will be held as a deposit. Loss damage and/or replacement cost (\$655) will be the responsibility of the competitor.
- 27.4 Additional machines require a separate transponder for each machine entered.

28. ONE EVENT NATIONAL LICENCE:

A One Event National Licence is available for Historic events only.

If required it <u>MUST BE APPLIED FOR 21 DAYS PRIOR</u> to the meeting. The cost of this licence is \$77.00 and an application form can be obtained from the Motorcycling NSW website: <u>www.motorcycling.com.au</u>

29. CAMPING AT SYDNEY MOTORSPORT PARK:

- 29.1 Friday 10th July and Saturday 11th July 2015
- 29.2 Limited sites (100 Adults)
- 29.3 Open to competitors, officials & their families (preference to interstate/country travellers).
- Camping facilities include: Unpowered sites only. No Power. Lighting supplied only to amenities block. Each section (Males/Females) includes: 6 showers, 4 hand basins, 6 cubicles & length of wall urinal (Men's only) & disabled facilities in both.
- 29.5 Gas BBQ's are permitted. NO OPEN/WOOD FIRES OR CAMPFIRES AT ANY TIME.
- 29.6 If you require power you will need to provide your own generator. However, we request that you do not have them running all night in respect for other campers.
- 29.7 Cost: \$50.00 per person. Children under 13 years are free.
