#### 1. **ANNOUNCEMENT**

The Queensland Early Motorcycle Sports Club Incorporated, hereafter called the PROMOTER will conduct the Stanthorpe test & tune practice weekend at Carnell Raceway, Stanthorpe, Old on Saturday and Sunday 5th & 6th of April 2014. The test and tune will be a non-competitive recreational event however lap timing services will be in place.

## 2.

- On-time entries open forthwith and close on Thursday 3rd of April. Late entries may be accepted up until Saturday the 5th of 2.1 March with a \$30 late payment fee.
- In the case of postponement or abandonment of the event, all or any part of the entry fee may be retained by the promoter, if 2.2 such retention is approved by Motorcycling Queensland.
- Only entries received on the official entry form that is accompanied by the correct fee will be accepted. 2.3
- RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING WILL BE CONSIDERED ONLY IF 2.4 NOTIFICATION IS GIVEN AT LEAST ONE WEEK PRIOR TO THE RACE DAY.
- 2.5 ALL ENTRIES TO BE POSTED TO: Rex Dell, PO Box 3188, Southport MC, Q. 4215
- Machines cannot be cross entered in more than one group. 2.6

#### **ENTRY FEE** 3.

- An on-time entry fee of \$70.00 will be charged for all senior solo and sidecar competitors which includes one transponder per entry. A late entry fee of \$30 will be charged for entries received after 3<sup>rd</sup> April. If any entrant wishes to run multiple machines in either one group or in multiple groups then the transponder they are allocated must be moved between machines. All entrants 3 1 must purchase as many transponder brackets as they require at a cost of \$10 each payable on the day. A \$50 cash deposit is also required for each transponder hire. All riders must have a current MA Competition or Recreational licence. For riders without a current MA Licence, One Event Recreational Licences are available at a cost of \$25.
- Payment by cheque, money order or EFT. ANY FEES FOR DISHONOURED CHEQUES WILL BE THE RESPONSIBILITY OF 3.2 THE ENTRANT. DO NOT SEND CASH THROUGH THE MAIL. - GROUPS: These are the approximate groups that will be run over the weekend.
  - 1 # Historic sidecars Period 3/4/5/6 & modern 2 # Historic Period 2 & Period 3

  - 3 # Historic Period 4 & Period 5
  - 4 # Historic Period 6, Modern & GP125
  - 5 # Pre 1991 regularity-type machines fast
  - 6 # Pre 1991 regularity-type machines slow
  - 7 # NCRR: Superlite, Motolite, Stockers & buckets

The intent of groups 5 & 6 is for entrants that normally compete in Regularity events or for those that wish to test out their older machines that they don't normally race. These 2 groups will be split into timed based groups after Saturday's practice sessions. Note: The exact make up of groups will be decided once entries close.

- 5 INSURANCE
- 5.1 MA's National Personal Accident Scheme provides basic cover for death and permanent disability only.
- 5.2 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE. ALTHOUGH ALL QLD RESIDENTS HAVE AUTOMATIC AMBULANCE COVER IT IS MANDATORY THAT INTERSTATE COMPETITORS TAKE OUT AMBULANCE COVER IN THEIR OWN STATE.

A QAS ambulance will be in attendance between 3pm-8pm on Saturday and 10am-4pm Sunday.

### 7. NOISE

ALL MACHINES MUST COMPLY WITH A 95dba RIDE BY TEST AT 30M FROM THE EDGE OF THE TRACK ( 2014 MANUAL OF MOTORCYCLE SPORT RULES 12.10 ) MACHINES MEASURED OVER 95dba WILL BE UNABLE TO PARTICIPATE UNTIL THE NOISE IS REDUCED TO THE ACCEPTED LEVEL.

#### 8. RIDERS BRIEFING

A riders briefing will be held prior to the commencement of the first practice session of each day and **ALL Entrants MUST attend**. Riders Briefing is a NON Smoking Area.

#### 9. CIRCUIT DESCRIPTION

Carnell Raceway is approximately 1 km in length. Its surface is constructed of hot mix bitumen. Riding will be conducted in a clockwise direction. Push starting of machines in pit lane will only be allowed in a southerly direction towards the entry gate.

# **IMPORTANT NOTES:**

- 1: **FUEL**: is not available at the track.
- 2: ALCOHOL: IS NOT PERMITTED WITHIN THE PIT AREA.
  RIDERS CONTRAVENING THIS RULE WILL BE EXCLUDED FROM THE DAY'S EVENTS.
- 3: CHILDREN ON WHEELED DEVICES: OF ANY KIND ARE NOT PERMITTED IN THE PIT AREA. These devises will be confiscated and returned at close of racing. CHILDREN UNDER 16 YEARS OF AGE ARE NOT PERMITTED IN THE PIT LANE.
- 4: **DOGS:** ARE **NOT** ALLOWED WITHIN THE CIRCUIT GROUNDS AT ANY TIME.
- 5: **FIRE EXTUNGUISHERS**: The promoter recommends that all competitors have a suitable fire extinguisher.
- 6: **NOVICE OR FIRST TIME TIMERS**: ARE REQUIRED TO BRING A WHITE T-SHIRT TO WEAR OVER THEIR LEATHERS TO MAKE IT EASIER FOR FASTER RIDERS TO IDENTIFY YOU.
- 7: CAMPING: Due to recent changes in the conditions of use of this facility no camping by any competitors can be allowed. A security guard or a member of the club will be on site all night. However some limited camping has been organized at the next door neighbours property. Please indicate number required where indicated on the entry form.
- 8: CANTEEN: The canteen will be open for lunch on Saturday, dinner on Saturday night & breakfast & lunch on Sunday.
- 9: CARNELL RACEWAY: address is Rifle Range Rd, Stanthorpe Qld.
- 10: **DIRECTIONS TO TRACK**: Drive through town and take first left after bridge (blue sign to refuse tip). Take second right which is Rifle range Rd. Drive down Rifle Range Rd for about one kilometre until you see a yellow sign on the right for Carnell Raceway.
- 11: PRACTICE STARTS: these will be held after dinner on Saturday night between 6.30pm & 8pm under lights on the existing drag strip track. No timing will be done for this event.
- 12: **SAFETY EQUIPMENT**: All entrants are required to wear either a full race outfit or for groups 5 & 6 an approved helmets, boots gloves & jeans.
- 13: TRACK LIMITATIONS: For groups 5 & 6 there is no engine capacity limit on what type of machines can be entered, however this is not a race event and a minimum lap time of 45 seconds will be enforced. Any rider below this minimum will be black flagged from this session. All other groups normal track limitations apply.

### CONTRACT TO PARTICIPATE IN THE QEMSC TEST & TUNE PRACTICE WEEKEND

#### WARNING! THIS IS AN IMPORTANT DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS, PLEASE READ IT CAREFULLY AND DO NOT SIGN IT UNLESS YOU ARE SATISFIED YOU UNDERSTAND IT.

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

#### 2. DEFINITIONS In this declaration:

- "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
- "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited; "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
- e) "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
- "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

### 3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

I ACKNOWLEDGE that:

- motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed;
- that my machinery or equipment may be damaged, lost or destroyed;
- that competitors may ride dangerously or with a lack of skill; that track or event conditions may be hazardous and may vary
- iv) without warning or predictability;
- v) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
- that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- that I have an obligation to myself and to others to act safely and vii) within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

### 4. WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are: - rendered with due care and skill;

- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and - reasonably fit for any particular purpose or might reasonably be
- expected to achieve any result you have made known to the

Supplier:
Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

I acknowledge and agree that if required, the Indemnitees (or any of

them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.
